# Exciting New Changes to Disney's Lightning Lane Service

### Message from Our Owner

This month is an exciting time for guests who are planning to visit Walt Disney World. In June, Disney announced updates and a rebrand to its old fastpass system (Genie + and Individual Lightning Lane) set to begin July 24th. The new service is named Lightning Lane Multi Pass and Lightning Lane Single Pass. Disney announced the change after receiving feedback from guests who desired to plan their park visits in advance. Lightning Lane Passes are a great way for guests to “skip the line” and squeeze in more of their favorite things to do during a park day.

We've done a lot of research on the new system and realize

these changes come as a “breath of fresh air” to many guests. Previously, guests could only book one attraction at a time on the day of their park visit with Genie +. Now with Lightning Lane Multi Pass, guests can book up to three attractions in advance, and once they redeem their first pass of the day, they can then book another. An added bonus is the ability to hold your selections in your cart for up to five minutes during your initial booking. Guests could not hold arrival times with the previous system. There are also more arrival times to choose from rather than having to select only what time is available. Overall, pricing for both Lightning Lane Multi Pass and Lightning Lane Single Pass are in a similar price range as Disney's most recent, previous system.

A few of our agents have already used Lightning Lane passes, and they noted that the initial booking was simple and easy to navigate. We have been excited all month to experience this change at Walt Disney World and Disneyland, and we know guests will be thrilled to be able to plan more

of their vacation in advance. Booking in advance adds an extra layer of confidence to your vacation, and you will be able to save time standing in line. The new Lightning Lane Passes are an upgrade from the old system, and guests can relax knowing their vacation details can be planned before they visit the parks. I can't wait to hear about more guests' experiences using Lightning Lane Passes, and I am excited to try it out myself!

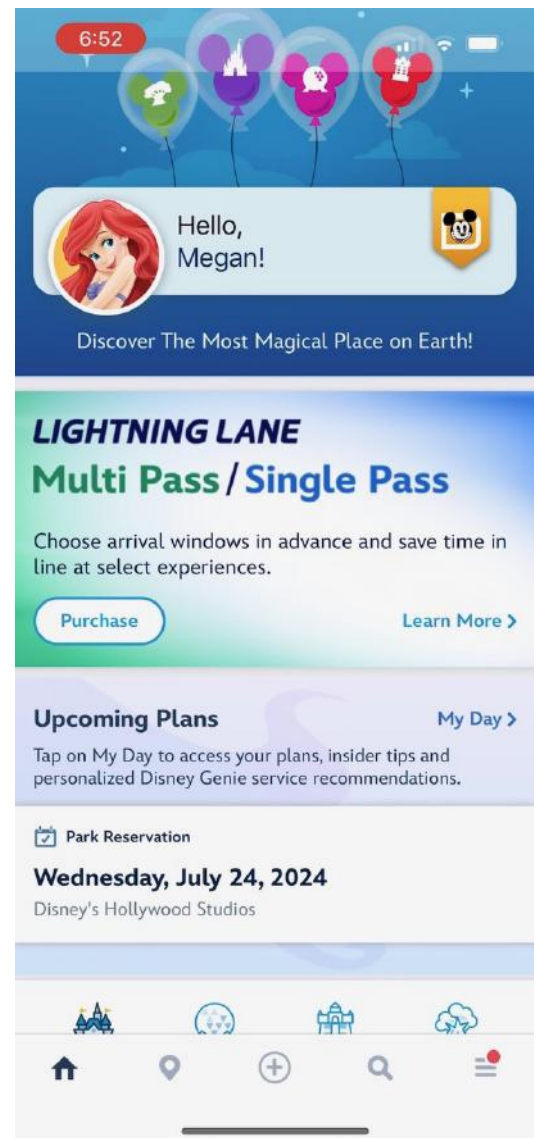

### Disney's New Lightning Lane Service is Here!

The highly anticipated launch of Walt Disney World's updated and rebranded fastpass system is here! Guests can now choose to purchase Lightning Lane Multi Pass and/or Lightning Lane Single Pass to "skip the line" on their next vacation. Passes can be booked through the My Disney Experience app. The new Lightning Lane Passes will allow guests to plan more of their vacation in advance rather than planning during their vacation. This provides guests with more confidence about what to expect, and it makes it easier for guests to plan ahead and save time in line.

With Lightning Lane Multi Pass, guests may book up to three attractions with specific arrival times in advance of their visit. Once a guest's first pass has been redeemed on the day of their visit, the guest is then eligible to book an additional attraction, subject to availability. Lightning Lane Single Pass allows guests to purchase up to two individual passes for more popular attractions not offered by Multi Pass.

Lightning Lane Passes can be booked through the My Disney Experience app. Guests staying at a Walt Disney World Resort Hotel and other select hotels (Swan and Dolphin Hotels, Shades of Green Resort) can book their passes up to 7 days in advance of their visit. Guests staying in other hotels or guests visiting for the day can purchase passes up to 3 days in advance of their visit.

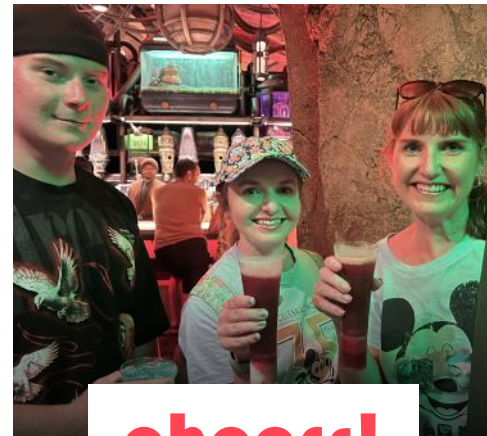
This past week was very special for me because my family from Pennsylvania came to visit. We had a wonderful week together full of lots of fun things in the Central Florida area.

The Genie+ system / Lightning Lane Multipass can provide a lot of value in helping you maximize your time on your Disney vacation. I think it will make for a more relaxed day.

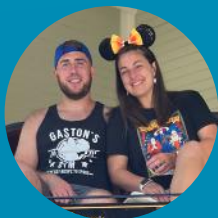

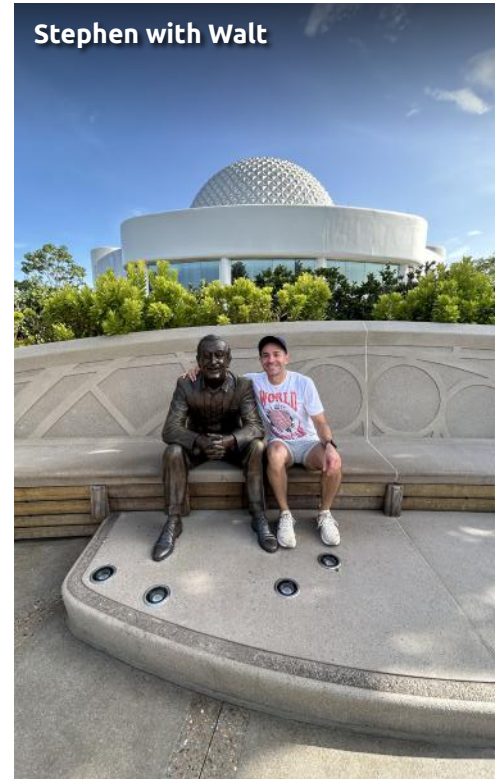

### What was the best part of your trip?

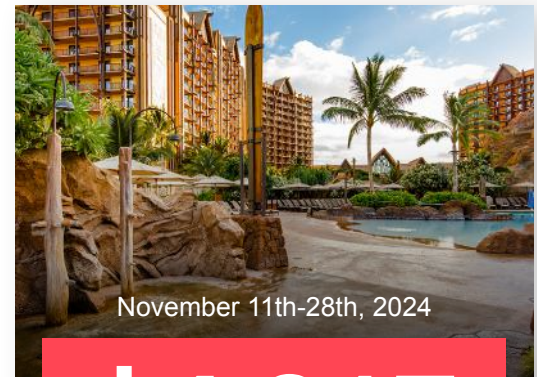

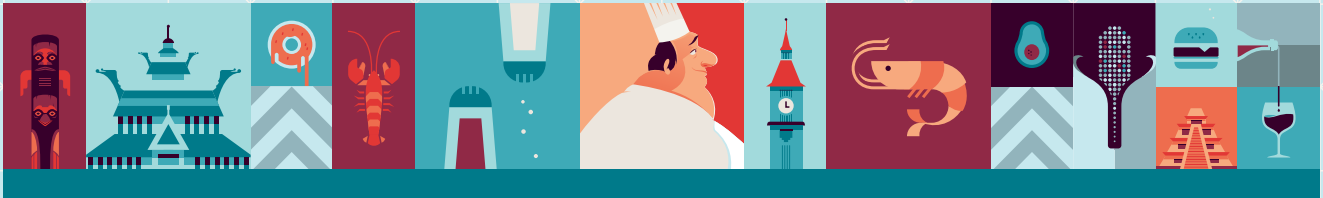

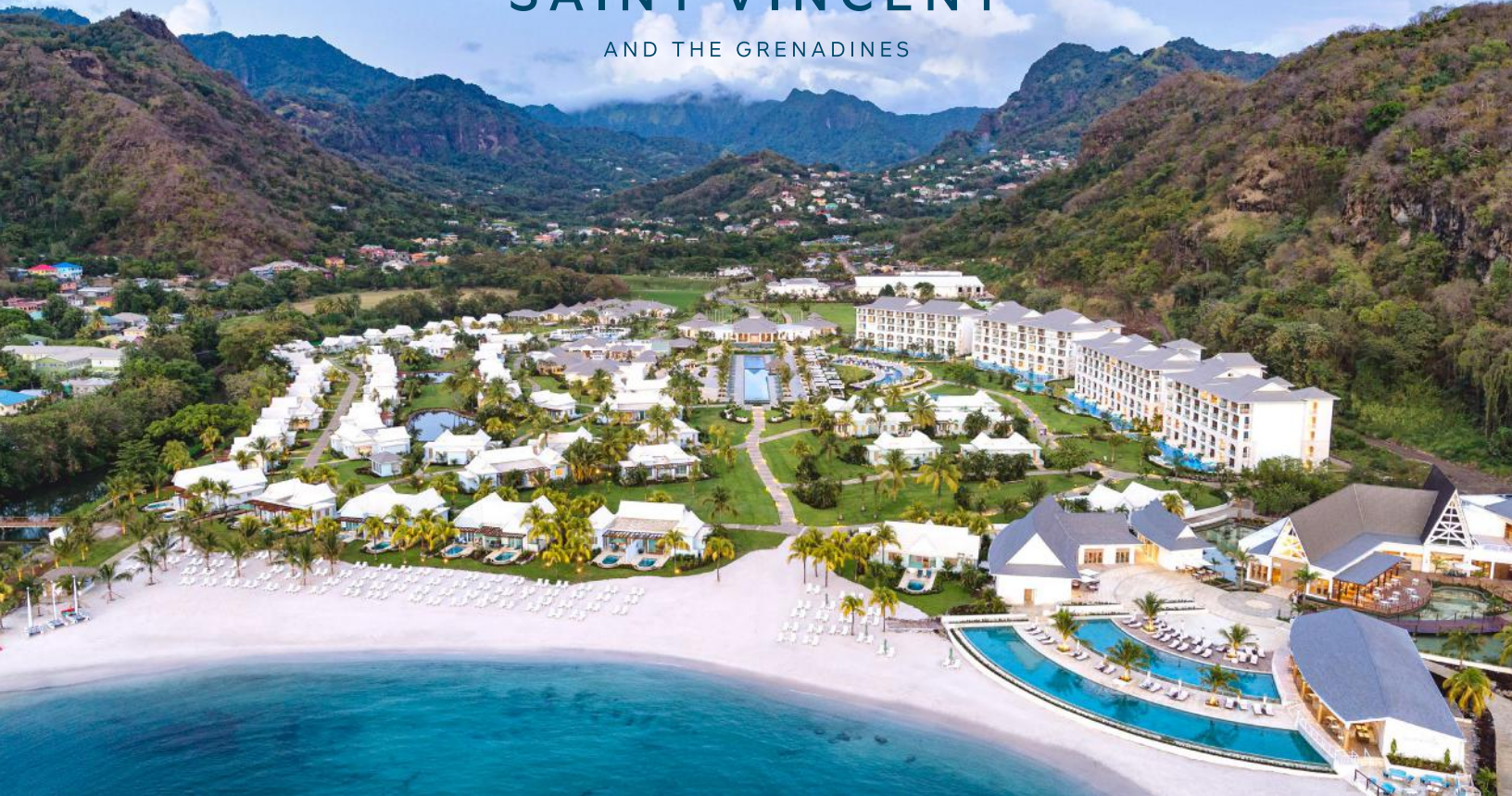
